A recipient of many local and international awards, Dato' Ahmad Nordin, 67, has had a long time of an illustrious career record. He had served both in the government and private sectors. To date, he had held a number of important posts in various major organisations. Currently, he is the honourable secretary general to the Regional Islamic Da'wah Council of Southeast Asia and the Pacific (RISEAP). He serves the Board of IKIM since 18 February 1992.

PROF. DR. MOHD. KAMAL BIN HASSAN

By profession, Prof. Dr. Mohd. Kamal bin Hassan, 51, is the Deputy Rector (Academic Affairs and Students' Discipline) of the International Islamic University. 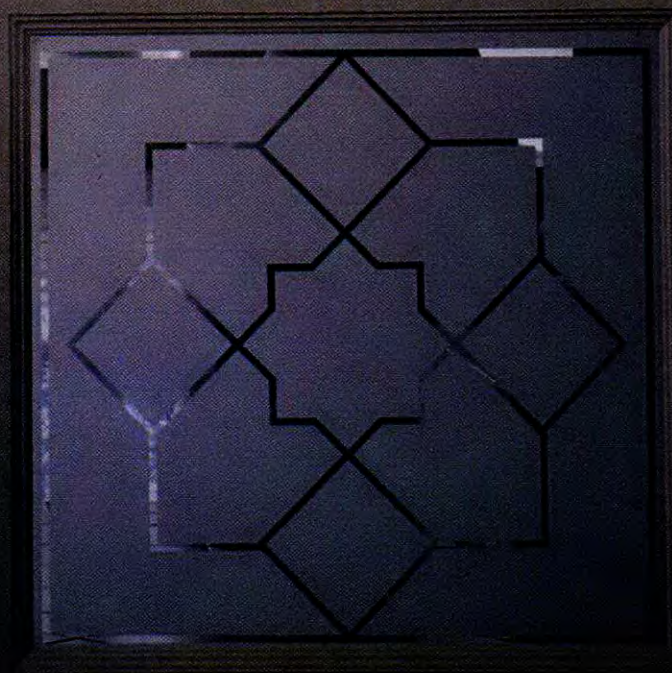
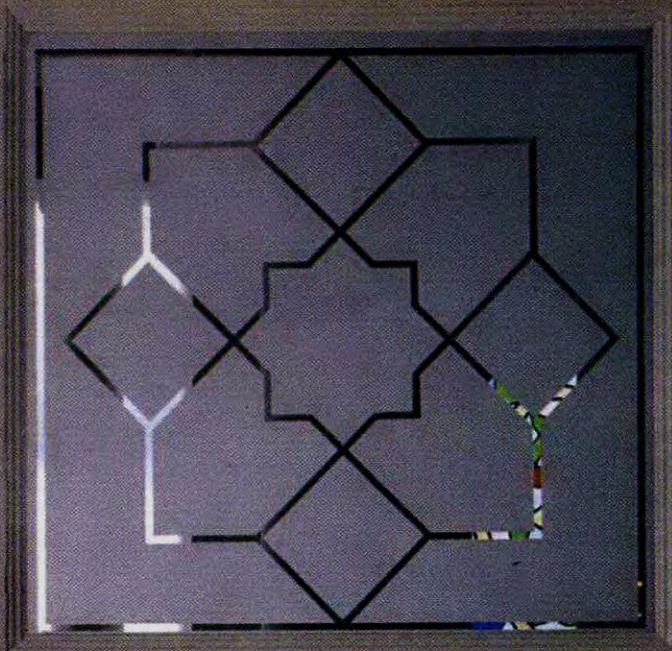
DATO' DR. ABDUL HALIM BIN HAJI ISMAIL

Penyata Pengerusi

IKIM yang telah didaftarkan sebagai sebuah syarikat berhad dengan jaminan di bawah Akta Syarikat 1965 pada 18 Februari 1992 dan dilancarkan pada 3 Julai 1992, oleh Y.A.B. Dato Seri Dr. Mahathir bin Mohamad, Perdana Menteri, mempunyai objektif-objektif seperti berikut:

- ☐ memperbetulkan imej Agama Islam yang telah dicemarkan oleh berbagai pihak sebagai agama yang dikatakan mempunyai ciri-ciri keganasan, konservertisma, fanatisme, kemunduran, kemiskinan dan aspek-aspek lain yang negatif;
- ☐ untuk menjelaskan kepada umum bahawa Islam adalah agama yang mendokong kebenaran, agama yang toleran, dinamik dan mempunyai nilai-nilai murni dan bercorak universal;
- ☐ untuk mengwujudkan suasana harmoni dan perasaan saling hormat menghormati, supaya orang-orang Islam boleh berbangga sebagai orang Islam dan orang bukan Islam merasa selamat di bawah undang-undang negara;
- ☐ untuk menjelaskan bahawa agama Islam adalah agama yang toleran;
- ☐ mengadakan forum bagi Sarjana Islam dan bukan Islam untuk membincangkan dan menganalisa isu yang menjadi kepentingan bersama;
- ☐ mewujudkan kesedaran dan kefahaman yang mendalam tentang isu-isu antarabangsa yang memberi kesan langsung kepada umat Islam.

Untuk mencapai matlamat penubuhannya, IKIM telah dan akan terus melaksanakan aktiviti-aktiviti berikut:

- ☐ menjalankan aktiviti penyelidikan yang melibatkan penyelidikan menyeluruh dan bersepadu tentang peranan Islam dan umat Islam untuk menghadapi cabaran semasa yang timbul akibat daripada keadaan dunia yang berubah-ubah bertujuan menyelesaikan isu-isu penting;
- ☐ menghasilkan penerbitan-penerbitan termasuk buku-buku, majalah-majalah dan jurnal untuk bacaan umum dan kumpulan sasar tertentu;
- ☐ menganjurkan persidangan, forum, perbincangan dan dialog untuk tujuan percambahan fikiran dan penyelesaian isu-isu tertentu;
- ☐ bekerjasama dengan agensi-agensi dan institusi tempatan dan luar negeri untuk menjalankan program-program bagi manfaat bersama.



Chairman's Statement

IKIM was registered as a limited company with a guarantee under the Company Act 1965 on 18 February 1992. Consequently, it was launched on 3 July 1992 by His Excellency Dato Seri Dr. Mahathir bin Mohamad, the Prime Minister. IKIM was established with the following objectives:

- ❑ to correct the image of Islam which has been tarnished by many ill-informed people that reflects Islam as a religion so dense with terrorism, conservatism, fanaticism, backwardness, poverty and other degrading aspects;
- ❑ to help explain to the masses that Islam is a religion that promotes the concept of truthfulness and that Islam itself is a religion that thrives on tolerance, dynamism and so full of extraordinarily pure and valuable universal precepts;
- ❑ to help nurture into society the harmonious living conditions whereby there are the feelings of mutual respect in which Muslims can feel worthy of being Muslims while the non-Muslims would feel secure under the laws embodied in the country's constitutions;
- ❑ to illustrate that Islam is a religion of tolerance;
- ❑ to provide a platform for Muslim and non-Muslims scholars so as to enable them to discuss or to analyse issues of mutual importance;
- ❑ to create indepth awareness and understanding of international issues that bring direct impact on Muslims.

As the means of achieving the objectives of which IKIM was formed, the following activities had been carried out and they will be continued.

- ❑ to carry out research activities that include intensive and integrated researches on the role of Islam and the ummah and how they are to face current challenges that come about as the result of the changing world scenario;
- ❑ to publish and issue newsletters, magazines, journals and books for public consumption and for specific target groups;
- ❑ to organise conferences, forums, discussions and dialogues so as to enrich and to encourage intellectual discourses and to help solve the prevailing issues;
- ❑ to cooperate with local and overseas organisations and institutions in undertaking joint programmes for mutual benefit purposes;

IKIM akan terus berusaha meningkatkan kefahaman masyarakat tentang ajaran dan nilai-nilai Islam serta hubungannya dengan kehidupan. IKIM akan terus membentuk pandangan-pandangan yang terbuka mengenai berbagai isu yang dihadapi oleh negara, Islam dan penganut-penganutnya.

Disepanjang tahun 1993, IKIM telah menjalankan berbagai program dan aktiviti seperti berikut:

- ☐ penerbitan buku;
- ☐ persidangan, seminar, bengkel, forum dan lain-lain;
- ☐ forum IKIM di Televisyen Malaysia;
- ☐ sumbangan artikel secara tetap di akhbar-akhbar tempatan;
- ☐ penerbitan majalah berkala seperti Perspektif, Visi dan Jurnal;
- ☐ lawatan dan rombongan;
- ☐ jaringan hubungan;
- ☐ terjemahan buku.

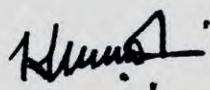

Saya berterima kasih kepada Kerajaan Persekutuan kerana telah membiayai pembinaan bangunan IKIM ini yang lengkap dengan kemudahan-kemudahan pejabat, perpustakaan, dewan besar, bilik persidangan, bilik pegawai-pegawai kanan, surau dan cafeteria.

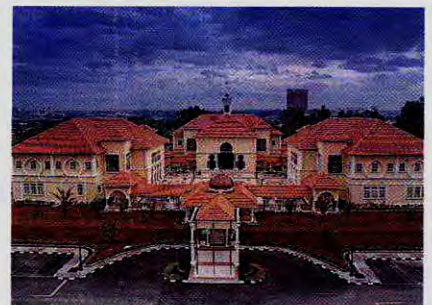

- ☐ Bertindak sebagai sumber maklumat bagi hal ehwal umat Islam.

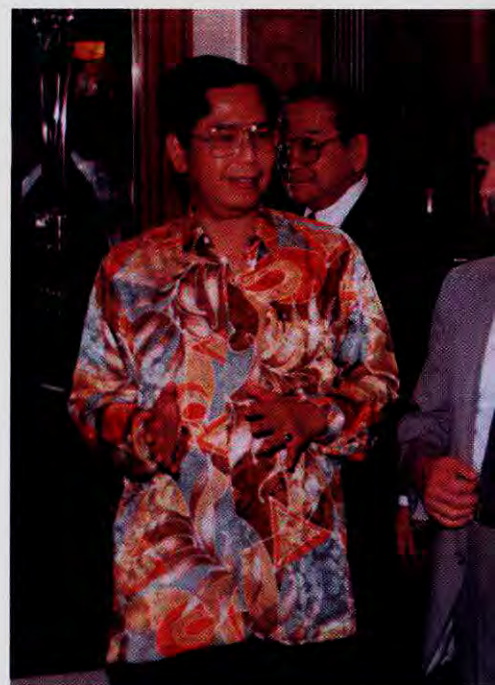
Laporan Kegiatan dan Pencapaian

Activities Report 1993

IKIM was established as a limited company with a guarantee under the Company Act 1965. It is administered by a Board of Directors which is directly answerable to His Excellency The Prime Minister. This institute was formed so as to achieve among others the following objectives:

- ❑ To carry out researches and consultancy works that involve complete and integrated efforts on the role of Islam and its ummah so as to enable them to face the realities of the contemporary world;
- ❑ To provide the avenues for Muslim and non-Muslim scholars to discuss and analyse matters of common interest;
- ❑ To create indepth awareness and understanding of international issues that are likely to have direct or indirect impact on Muslims; and
- ❑ To be the source of information concerning the Muslims' affairs.



Activities and Achievements Report

IKIM is administered by a Board of Directors in which the Honourable Tan Sri Dato' Seri Ahmad Sarji bin Abdul Hamid is the Chairman who at the same time is the Chief Secretary to the Government. This appointment was conferred upon him by His Excellency the Prime Minister, thus, honouring him of being the very first IKIM Chairman starting 15 Mac 1992.

Consequently, the Prime Minister had also appointed Dato' Dr. Ismail bin Haji Ibrahim, member of the Board of Directors, as IKIM's first Director-General commencing 16 April 1992. Tuan Haji Subhan bin Jasmon was appointed as the Secretary. He was a senior officer with the Public Services Department attached to IKIM since 16 April 1992.

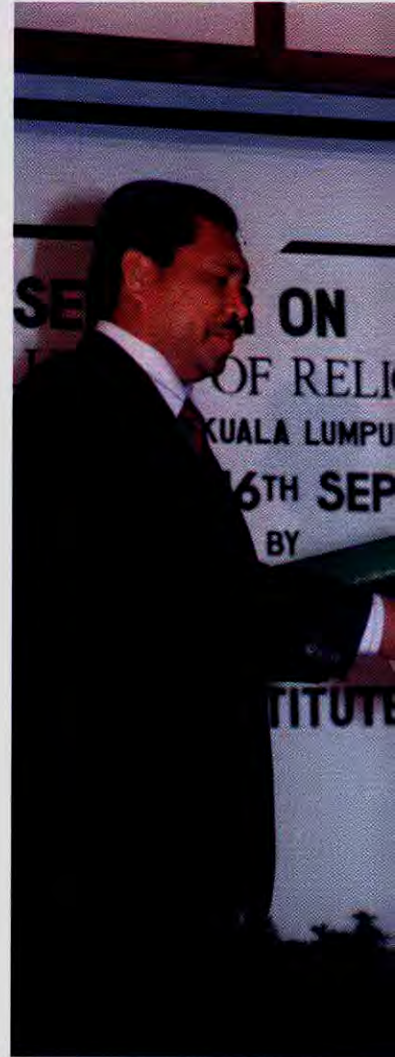

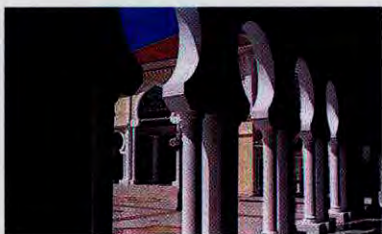

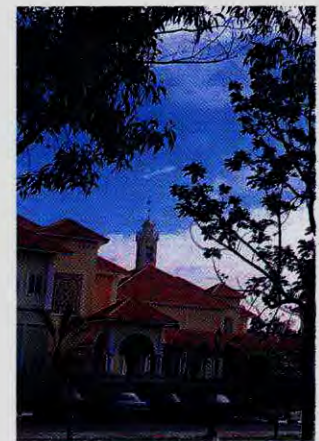

IKIM had established mutual understanding and had formally signed the Memorandum of Understanding with the Research Centre for Islamic History, Art and Culture (IRCICA) and The Foundation for Research in Islamic Sciences on 11–18 June 1993. Both institutions are based in Turkey.

IKIM Building

IKIM started operating at a rented office space located in Pusat Bandar Damansara until October 1993. Upon the completion of IKIM's permanent office premises comprising a cluster of impressive structures located at the fringe of Jalan Langgak Tunku, the whole of IKIM's operations are centred here. The new premises are made up of three main 2-storey blocks comprising office spaces, a library, a conference hall, meeting rooms and a cafeteria. Apart from these facilities, there is a big courtyard conceived in an imaginary manner complete with fountains, plants and flowers. Within this captivating setting too, there is Taman Firdausi which is wreathed with an inviting arbour of flowers and decorative shrubs, all planted according to a designer's sense of colours and patterns existing in affectionate struggle with taller trees. The whole cost of these premises came to RM8.3 million.
