CHAIRMAN'S STATEMENT

Throughout 1996, IKIM continued its efforts to increase society's understanding of Islamic teachings and values and their relevance to daily life. The following programmes and activities were carried out, viz research, book publishing, conferences, seminars, workshops, forums, dialogues, lectures and others; IKIM's forum on Radio Televisyen Malaysia; regular contribution of articles to local newspapers; periodic publications, namely, *Perspektif*, *Visi* and *Jurnal*; host to local and foreign visitors, communications network and translating classical books on Islam.

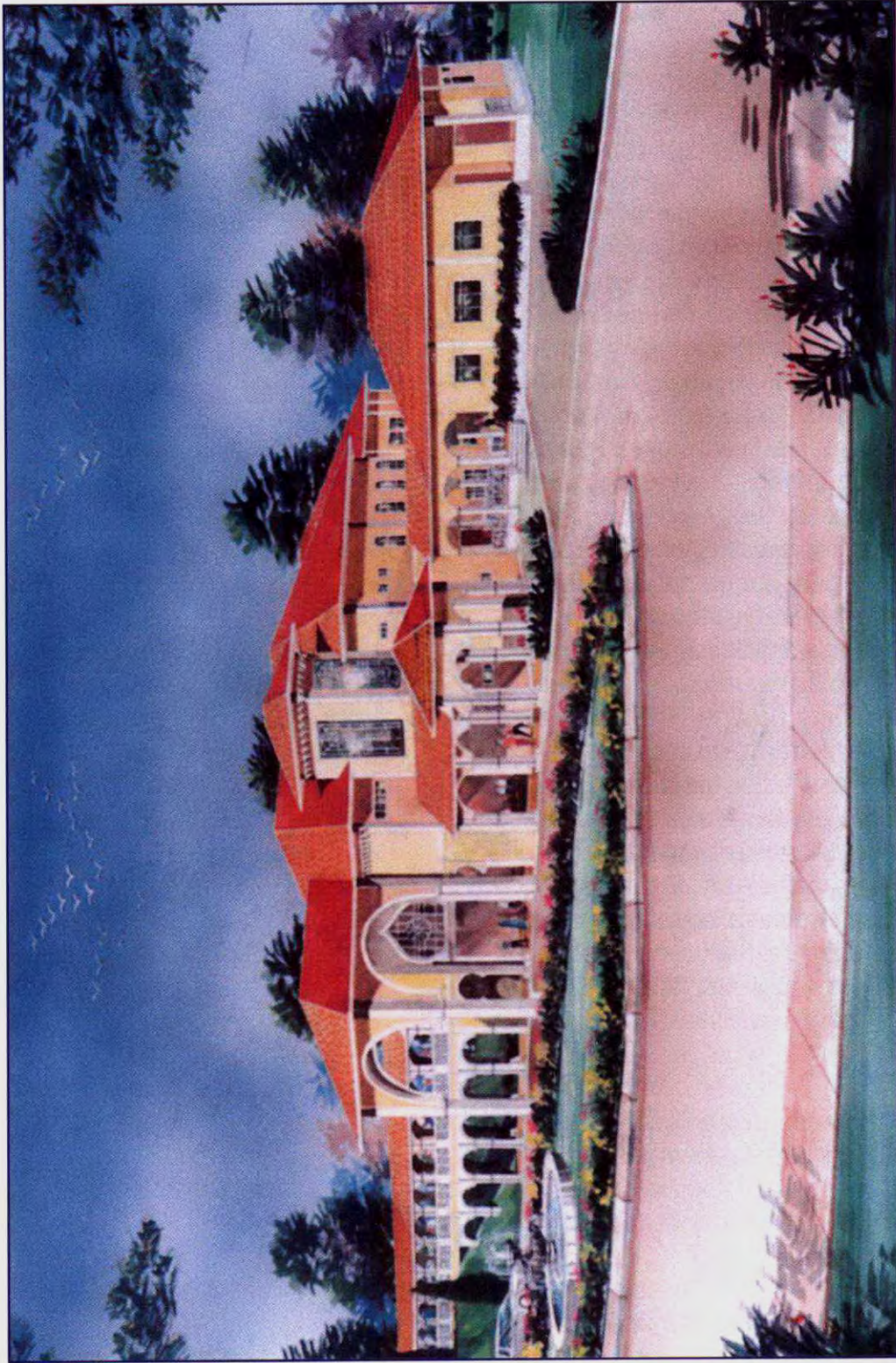

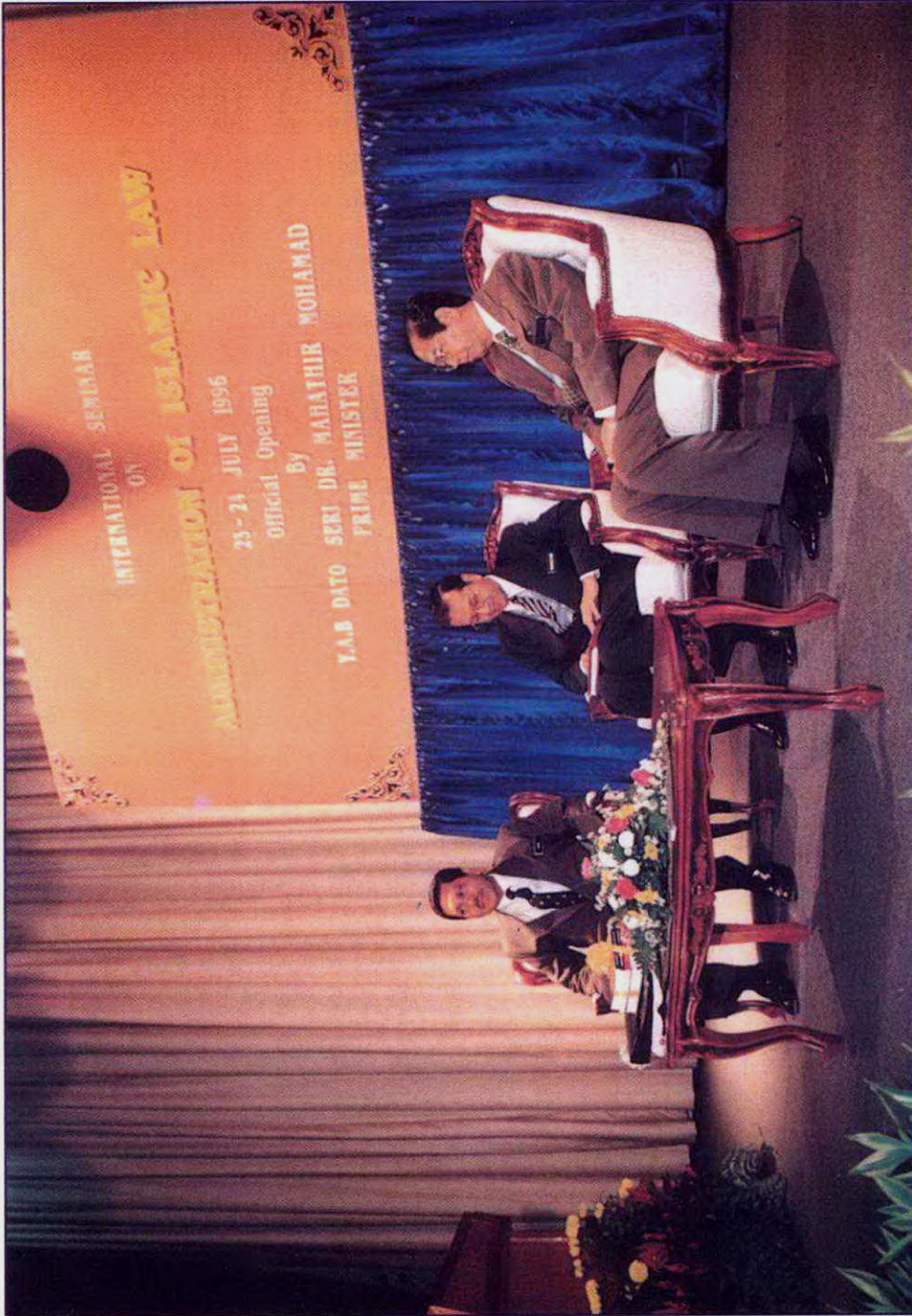

LAPORAN AKTIVITI BAGI TAHUN 1996

Penubuhan dan Matlamat

IKIM, yang ditubuhkan sebagai sebuah syarikat berhad dengan jaminan di bawah Akta Syarikat 1965, adalah ditadbirkan oleh sebuah Lembaga Pengarah.

Institut ini ditubuhkan untuk mencapai objektif berikut:

- ❖ Menjalankan aktiviti penyelidikan dan aktiviti rundingan yang akan melibatkan penyelidikan menyeluruh dan bersepadu tentang peranan Islam dan umat Islam untuk menghadapi hakikat semasa;
- ❖ Sebagai forum bagi sarjana Islam dan bukan Islam untuk membincangkan dan menganalisis isu yang menjadi kepentingan bersama;

KEGIATAN DAN PENCAPAIAN

Lembaga Pengarah

IKIM telah ditadbirkan oleh sebuah Lembaga Pengarah terdiri daripada 11 orang ahli, enam daripadanya merupakan ahli lantikan Kerajaan (Government Nominees) dan lima orang ahli dilantik oleh Mesyuarat Agong Tahunan. Lembaga Pengarah IKIM dipengerusikan oleh Y.Bhg.

ACTIVITIES REPORT FOR 1996

Establishment and Objectives

IKIM, which was established as a private limited company with guarantee under the Companies Act 1965, is administered by a Board of Directors.

The institute is established to achieve the following objectives:

- ❖ To carry out research and consulting activities which will involve total and integrated research on the role of Islam and Muslims to face current realities;
- ❖ To become a forum for Muslim and non-Muslim scholars to discuss and analyse issues of mutual interest;
- ❖ To create awareness and deep understanding of international issues which may have direct or indirect impact on the Muslims; and
- ❖ To act as a source of information on Muslim affairs.

REPORT ON ACTIVITIES AND ACHIEVEMENTS FOR 1996

Board of Directors

IKIM has been administered by a Board of Directors comprising 11 members, six of whom are Government Nominees and five members appointed by the Annual General Meeting. The IKIM Board of Directors is chaired by Y.Bhg. Tan Sri Dato' Seri (Dr) Ahmad Sarji bin Abdul Hamid, who was appointed by Y.A.B. the Prime Minister as the first Chairman of IKIM on 15 March 1992 while Y.Bhg. Dato' Dr. Ismail
