Round Table Conference on "The Federal Constitution & Maqasid Al-Shari'ah"

Persidangan Meja Bulat ini diadakan dengan matlamat membincangkan kepentingan pandangan alam Islam dalam pentafsiran peruntukan dalam Perlembagaan, mengupas pendirian dan sikap agama terhadap kehidupan sekular, menilai sejauh manakah Perlembagaan Malaysia/Persekutuan menepati Maqasid al-Syari'ah dan membahaskan perbandingan antara sifat-sifat asasi Maqasid al-Syari'ah dengan Perlembagaan Persekutuan.

The Round Table Conference was organised with the aim of discussing the importance of the worldview of Islam in interpreting the provision of the Constitution, to highlight the stance and attitude of religion toward secular life, to assess the extent of the Malaysian Constitution/Federal in meeting Maqasid al-Shari'ah and to discuss the comparison between the fundamentals of Maqasid al-Shari'ah in the Constitution.

TALK on "The Moral Conduct of Rasulullah's SAW" was delivered by Ustaz Zulramli bin M. Razali for the staff of the Ministry of Higher Education (MoHE) at Presint 5, Putrajaya which was coordinated by the IKIM Programmes Unit. It was attended by 200 participants.

“Pendekatan Fiqh Ta’amul dalam Hubungan antara Penganut Agama”

II PENDEKATAN Fiqh Ta’amul dalam Hubungan antara Penganut Agama” bertujuan untuk menghuraikan bagaimana masyarakat majmuk yang menganut pelbagai agama mengikut pendekatan yang dinamakan fiqh al-ta’amul (fiqh berkaitan pergaulan dan interaksi). Pendekatan ini dapat membantu menyediakan garis panduan bagi pihak kerajaan dan masyarakat, umumnya ke arah menjadikan Islam sebagai agenda membangunkan masyarakat majmuk yang harmoni.

Seharusnya umat Islam di Malaysia menerajui usaha membina hubungan baik ini agar seiring dengan prinsip asas Islam dalam memelihara keadilan dan keamanan untuk semua umat manusia. Terdapat riwayat-riwayat hadis yang menunjukkan bahawa Nabi SAW berinteraksi dengan manusia berdasarkan tahap dan cara pemikiran mereka dan suasana, serta ada juga

riwayat yang mencatatkan tentang kewujudan golongan bukan Muslim yang hidup dengan harmoni di bawah pentadbiran pimpinan Rasulullah SAW di Madinah. Riwayat-riwayat yang pelbagai ini memberikan suatu bentuk konsep bagaimana untuk berinteraksi dengan masyarakat bukan Muslim.

“*The Fiqh Ta’amul Approach In Relationships Between Religious Adherents*”

II THE FIQH Ta’amul Approach in Relationships between Religious Adherents” was aimed at explaining how a pluralistic society that embraces various religions according to the approach called fiqh al-ta’amul (jurisprudence understanding regarding associations and interactions). The approach can help provide guidelines for the government and society, generally towards making Islam the agenda for developing a harmonious society.

Muslims in Malaysia should take the lead in building good relationships so as to be consistent with the fundamental principles of Islam in maintaining justice and peace for all mankind. There are Prophetic narrations indicating that the Prophet interacted with human beings

based on their level and way of thinking and the surroundings, and some narrations recorded the existence of non-Muslims living in harmony under the administrative leadership of the Prophet Muhammad in Medina. These narrations provide a concept of how to interact with non-Muslims.

“Kajian Keberkesanan Kurikulum Pelajaran Pendidikan Islam Bagi Menghadapi Cabaran Masa Kini”

KAJIAN ini bertujuan untuk menilai keberkesanan Pengajaran dan Pembelajaran (P&P) mata pelajaran Pendidikan Islam (PI) daripada aspek penggunaan bahan sumber pembelajaran, kaedah Pengajaran dan Pembelajaran (P&P), pentaksiran, sukanan pelajaran dan masalah, dan cabaran dari perspektif guru yang mengajar Pendidikan Islam dan pelajar. Kajian ini dijalankan dengan kerjasama IKIM-UIAM-KPM.

Kajian ini telah dilaksanakan menggunakan reka bentuk penyelidikan, iaitu kaedah kuantitatif dan kualitatif. Reka bentuk penyelidikan kuantitatif membabitkan penggunaan metodologi tinjauan menerusi dua instrumen soal selidik berasingan bagi guru dan pelajar.

Kajian ini telah menghasilkan beberapa penemuan yang diringkaskan seperti berikut: Pada keseluruhannya, guru Pendidikan Islam (i) menggunakan pelbagai bahan sumber pembelajaran, tetapi yang paling kerap adalah buku teks dan bahan tambahan seperti buku aktiviti; (ii) mengamalkan kaedah P&P yang lebih berorientasikan kaedah berpusatkan guru iaitu bersyarah, bercerita dan memberi nota, dan lebih diimbangkan dengan kaedah berpusatkan pelajar seperti inkuiiri dan perbincangan di sekolah menengah; (iii) menghadapi masalah pentaksiran untuk Pentaksiran Berasaskan Sekolah (PBS)

dalam membina soalan berbentuk Kemahiran Beraras Tinggi (KBAT) dan menyatakan keperluan untuk kursus lanjutan; (iv) bersetuju dengan kepadatan sukanan pelajaran dan beberapa kekurangan yang boleh dibaiki; (v) berhadapan dengan masalah P&P yang di luar kawalan mereka dan masalah pelajar yang lemah dalam bacaan al-Quran dan Jawi.

Penemuan bagi guru Pendidikan Islam dalam aspek (i), (ii) dan (v) ini dikukuhkan oleh penemuan daripada pelajar SK dan SMK berdasarkan soal selidik dan juga perbincangan kumpulan fokus guru dan pelajar. Pelajar SMK didapati mempunyai sikap positif terhadap bacaan Jawi, tetapi 29 peratus kurang upaya dan tidak lancar dalam tulisan Jawi dan hampir separuh tidak setuju ia digunakan untuk kerja latihan dan ujian. Malahan, majoriti besar iaitu 78 peratus lebih suka belajar Pendidikan Islam dalam Rumi. Kajian menemui perbezaan yang signifikan antara guru SK dan SMK, dan guru Zon Malaysia Barat dan Timur dalam beberapa aspek, antaranya kaedah P&P dan pembacaan al-Quran. Akhirnya, kajian ini mencadangkan beberapa langkah untuk menambah baik P&P Pendidikan Islam pada masa depan.

Pembentangan Kajian bertajuk “Keberkesanan Pendidikan Islam” IKIM-UIA-BPI telah dilakukan di Bahagian Pendidikan Islam (BPI), Cyberjaya pada 29 April 2016.

“Research on the Effectiveness of Islamic Studies Curriculum in Facing Current Challenges”

THE research was aimed at evaluating the effectiveness in the Teaching and Learning (T&L) of Islamic Education (IE) subjects from the aspect of the usage of learning resource materials, methodology in T&L, assessments, syllabus and problems, and challenges from the perspectives of the teachers who teach IE and students. The research was conducted with the cooperation of IKIM-UIAM-KPM.

The research designs used were quantitative and qualitative methods. The quantitative research method comprised the use of the survey methodology by two separate questionnaire instruments for teacher and student.

Findings of the research are summarised as follows: On the whole, Islamic Education teachers (i) use a variety of learning resources, but most commonly textbooks and supplementary materials such as activity books; (ii) practise the T&L method which is more teacher-focussed oriented that is lecture, story-telling and notes-giving, and more balanced with student-focussed method that centres on enquiries and discussions at secondary school; (iii) Faced with assessment problems for the School-Based Assessments in building questions of High Level Skills and expressing their needs for advanced courses; (iv) agree

on the density of syllabus and several shortcomings that can be rectified; (v) Faced with T&L problems which are beyond their control and problems of students weak in reading the Quran and Jawi.

Findings of the Islamic Education teacher in the aspects of (i), (ii) and (v) were confirmed by findings from the SK and SMK students based on questionnaires and teacher and student focus group discussions. SMK students were found to have positive attitude towards Jawi reading, but 29 per cent were less able and less fluent in the Jawi script and almost half did not agree it was used for training and tests. In fact, the overwhelming majority of 78 per cent preferred to learn Islamic Education in Rumi. Research has found significant differences between SK and SMK teachers, and teachers in the West and East Malaysia Zones in several aspects, including T&L method and the reading of the Quran. Finally, the research recommended several measures to improve T&L of Islamic Education for the future.





