

Disepanjang tahun 2002 IKIM telah mengadakan dua (2) seminar antarabangsa, sembilan (9) seminar kebangsaan, tiga (3) muzakarah pakar, empat (4) forum, tiga (3) bengkel, satu (1) dialog, satu (1) syarahan dan satu (1) majlis debat .

Salah satu tajuk yang menarik adalah 'Living Together in Plural Society'. Toleransi berugama adalah dilihat sebagai faktor utama bagi keamanan dan kestabilan sebuah negara berbagai kaum dan agama seperti Malaysia. Satu lagi tajuk seminar adalah 'Ke Arah 20% Pasaran Perbankan Menjelang 2010: Strategi Sistem Perbankan Islam'. Pakar-pakar telah membincangkan kaedah-kaedah yang boleh meningkatkan lagi kapasiti perbankan, perkhidmatan dan kemudahan kewangan Islam. Seminar mengenai 'Memahami Malaysia sebagai Sebuah Negara Islam', mendapati pengisytiharan Malaysia sebagai sebuah negara berasaskan Islam adalah benar berdasarkan dari kemajuan yang dicapai dalam bidang-bidang ekonomi, pendidikan, dasar luar negara, perundangan, cara hidup dan lain-lain yang membangunkan ummah.

Sempena ulangtahun ke sepuluh penuh IKIM, satu seminar antarabangsa telah diadakan pada 22-23 Oktober bertajuk "Gold Dinar In Multilateral Trade". Seminar ini merumuskan bahawa dinar boleh digunakan di kalangan beberapa negara Islam untuk permulaannya.

Pada tahun 2002, IKIM telah berkerjasama dengan kerajaan-kerajaan negeri Pahang, Kedah, Selangor dan Pulau Pinang . Di Kuantan,

In the name of Allah, Most Gracious and Most Merciful, on behalf of the Board of Directors, it is with great pleasure that I present the progress report and audited financial statements of the Institute of Islamic Understanding Malaysia for the year 2002.

Various programmes and activities were organised during the year 2002 which include two (2) international seminars, nine (9) national seminars, three (3) expert consultations, four (4) forum, three (3) workshops, one (1) dialogue, one (1) lecture and one (1) debate.

One of the interesting topics was "Living Together in Plural Society". Religious tolerance was viewed to be the key factor for a peaceful and stable multi-ethnic and multi-religious country like Malaysia. The other interesting topic was "Towards 20 percent of the Banking Market by 2010: The Strategies of the Islamic Banking System". The experts discussed the methodologies towards achieving 20 percent of the banking market by Islamic banks in Malaysia including efforts towards increasing the capacity of Islamic banking, products and services. The seminar on "Understanding Malaysia As An Islamic State", confirmed the declaration that Malaysia is an Islamic state based on the achievement in the fields of economy, education, foreign policy, laws and way of life etc. which develop the ummah.

To mark the tenth anniversary of IKIM, an international seminar was held on 22-23 October entitled "Gold Dinar in Multilateral Trade". This seminar resolved that the dinar could be used by a few Islamic countries for a start.

During the year 2002, IKIM cooperated with the State governments of Pahang, Kedah, Selangor and Pulau Pinang. At Kuantan, the multaqa Sultan Ahmad Shah was held on 14-15



Pahang, multaqa Sultan Ahmad Shah mengenai "Memahami Konsep dan Peranan Ulil-Amri di Malaysia" telah diadakan pada 14-15 Oktober. Seminar ini telah menjelaskan bahawa Islam menyarankan kepimpinan secara kolektif dan tidak membayangkan penguasaan kuasa politik oleh individu. Ia menekankan kepentingan prinsip-prinsip "shura" di mana terdapat penyertaan kedua-dua pemerintah dan rakyat di dalam pemerintahan negara. Di Bedong, Kedah, seminar mengenai "Memahami isu-isu Pendidikan Islam Di Malaysia" yang diadakan pada 20-21 Mei telah menyarankan supaya kurikulum pendidikan Islam yang bersepadu perlu diseragamkan di semua peringkat Sekolah Agama diseluruh negara. Manakala di Pulau Pinang satu muzakarah pakar mengenai "Perlaksanaan Hukum Syarak di Malaysia" telah diadakan pada 19-20 Mac, mencadangkan penyeragaman pelaksanaan hukum syarak di peringkat Negeri dan Persekutuan.

Usaha Institut ini untuk menyebarkan kefahaman Islam kepada masyarakat telah diperkuuhkan lagi dengan penerbitan sebanyak sebelas (11) buah buku ilmiah , empat (4) jurnal berkala dan empat (4) majalah VISI. Sebagai tambahan kepada usaha itu, IKIM masih terus menyumbang artikel-artikel mengenai isu-isu semasa di akhbar-akhbar tempatan. Bagi tahun 2002 sebanyak tiga puluh tiga (33) artikel diterbitkan oleh Utusan Malaysia, dua puluh sembilan (29) artikel oleh Berita Harian, dua puluh empat (24) artikel oleh The New Straits Times dan enam (6) artikel oleh The Star. Isu-isu penting yang diliputi diantaranya adalah mengenai Islam dan Tadbir Urus Korporat, Sistem Kewangan Islam, Etika Perniagaan Dalam Islam, ICT dalam konsep ilmu Islam, definisi Patriotisme, Nilai-nilai Moral, Wanita Islam Berkerjaya, Pengurusan wakaf dan Kerelevan Sains kepada Islam.

October entitled "Understanding the Concept and Role of Ulil-Amri in Malaysia". This seminar clarified that Islam upholds collective leadership and does not envisage concentration of political power in one individual. It emphasizes the importance of the principle of 'shura' in the context of the participation of both the ruler and the ruled in the conduct of government. At Bedong, Kedah, the seminar on "Understanding the Issues of Islamic Education in Malaysia" held on 20-21 May proposed that an integrated curriculum of Islamic education be introduced at all levels of religious schools in Malaysia. The expert consultation on "The Implementation of Shariah Laws in Malaysia" held on 19-20 March at Pulau Pinang proposed the uniformity of the implementation of Shariah Laws at both State and Federal levels.

The Institute's effort in providing the understanding on Islam to the society has been further intensified through the publication of eleven (11) academic books, four (4) periodical journals and four (4) issues of VISI magazines . In addition, IKIM staff contributed articles to most of the major local newspapers on contemporary issues. For the year 2002, there were thirty three (33) articles published in Utusan Malaysia, twenty nine (29) articles in Berita Harian, twenty four (24) articles in The New Straits Times and six (6) articles in The Star. Among the issues covered were Islam and Corporate Governance, Islamic Financial System, Business Ethics in Islam, ICT in the concept of Islamic Knowledge, definition of Patriotism, Moral Values, Career Muslim Women, Management of Waqaf, and the Relevance of Science to Islam.

Bagi menambahkan lagi bahan bacaan yang berkaitan dengan kefahaman Islam untuk masyarakat di Malaysia, IKIM sedang menterjemah beberapa buku yang ditulis dalam Bahasa Arab kepada Bahasa Malaysia antaranya buku-buku "Al-Akhlaq Al-Islamiah" Jilid 1 , "Adab Al-Qadhi" dan "Hujjatullah Al-Balighah".

Radio IKIM.Fm telah menyiarakan program-program untuk memberi kefahaman mengenai prinsip-prinsip dan nilai-nilai Islam dalam bidang ekonomi, pengurusan, perniagaan, kewangan, undang-undang syariah, sains politik, alam sekitar, pertanian, pelancongan dan rekreasi. Disamping itu, IKIM juga telah menyertai program-program tajaan televisyen Malaysia sebanyak dua puluh tiga (23) slot "Bicara Islam" di TV1 sepanjang tahun 2002.

Sempena ulangtahun kesepuluh penuhnya IKIM, satu pameran telah diadakan, dan "sampul kenang-kenangan" berserta dengan setem IKIM berukuran 38mm x 38mm dikeluarkan oleh pihak Pos Malaysia dan dirasmikan oleh YAB Dato' Seri Dr.Mahathir Mohamad, Perdana Menteri pada 23 Oktober 2002.

Pada tahun 2002, delegasi dari negara luar yang melawat dan mengadakan perbincangan dengan pegawai-pegawai IKIM diantaranya adalah Ahli-ahli Kongres dan Pegawai-pegawai Tentera Amerika Syarikat; Jabatan Agama Riau Indonesia; Menteri Hal Ehwal Agama, Zakat dan Ushr Pakistan; Pegawai-pegawai Pentadbiran Agama, Kementerian Hal Ehwal Agama, Negara Brunei Darussalam; Pegawai-pegawai Kanan Kementerian Pendidikan Kuwait; wakil daripada Center for the Study of Muslim Networks, Universiti Duke, Carolina Utara, Wartawan-wartawan kanan daripada Amerika Syarikat dan wakil daripada World Council of Muslims for Interfaith Relations, Australasia.

In order to further equip the society with more knowledge and understanding on Islamic principles, this Institute undertook the translation into Bahasa Malaysia of books written in Arabic entitled "Al-Akhlaq Al-Islamiah" 1<sup>st</sup> Volume, "Adab Al-Qadhi" and "Hujjatullah Al-Balighah".

Radio IKIM.Fm broadcast programmes relating to the understanding of Islamic principles and values in such areas as economy, management, business, finance, syariah laws, political science, environment, agriculture, tourism and recreation. In addition, this Institute actively participated in RTM programmes recorded on twenty three (23) slots for "Bicara Islam" of TV1 during the year 2002.

For the tenth anniversary celebration, the Institute put up an exhibition; Pos Malaysia produced a "first day cover souvenir" printed on an envelop together with stamp of 38mm x 38mm and was launched by YAB Dato'Seri Dr.Mahathir Mohamad, the Prime Minister on 23 October 2002.

During the year 2002, the foreign delegates who visited the Institute and held discussions with officials include Congressmen and Army Officers from the United States of America; Officers from the Religious Department of Riau Indonesia; Minister of Religious Affairs, Zakat and Ushr, Pakistan; Officers from Religious Affairs Department, Brunei Darussalam; Senior Officers from the Education Ministry, Kuwait; Representative of the Centre for the Study of Muslim Networks, University of Duke, North Carolina; Senior reporters from the United States of America and Members of the World Council of Muslims for Interfaith Relations, Australasia.


