Chairman's KENYATAAN PENERUS Statement



Dengan nama Allah Yang Maha Pengasih dan Penyayang, saya bagi pihak Lembaga Pengarah dengan sukacitanya membentangkan laporan mengenai aktiviti-aktiviti utama dan penyata kewangan Institut Kefahaman Islam Malaysia (IKIM) yang telah diaudit untuk tahun 2003.

Sepanjang tahun 2003, IKIM telah menganjurkan sebanyak tiga (3) seminar antarabangsa, lapan (8) seminar kebangsaan, tiga (3) muzakarah pakar, dua (2) forum, dua (2) persidangan, satu multaqa, debat dan bengkel bertujuan untuk memantapkan kefahaman masyarakat mengenai prinsip-prinsip Islam.

Beberapa seminar itu telah menghasilkan cadangan-cadangan yang penting. Seminar mengenai "Ulama Pewaris Anbia" telah mencadangkan pengwujudan jawatan "mufti kebangsaan" dan juga penubuhan sebuah badan autonomi yang akan memantau dan memperkemas peranan dan aktiviti-aktiviti ulama di negara ini.

Seminar yang bertajuk "Sistem Keadilan Jenayah Islam" telah mencadangkan bahawa sebelum memperkenalkan undang-undang jenayah islam (hudud), sebuah Panel Ulama Antarabangsa perlu ditubuhkan untuk mengkaji pelaksanaan hukum ini di dalam sebuah negara yang mempunyai penduduk beraneka agama. Seminar ini juga mengesyorkan bahawa Jabatan Perundangan Syariah Malaysia, yang

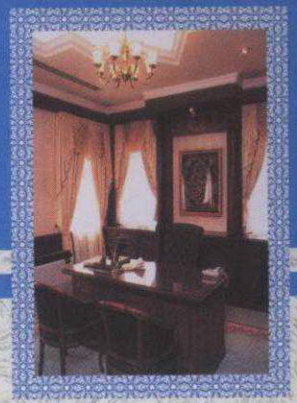
In the name of Allah the Most Gracious and Most Merciful, on behalf of the Board of Directors, I hereby present a report on the major activities of the Institute of Islamic Understanding Malaysia (IKIM) and the audited financial statements for the year ended 2003.

Throughout the year 2003, IKIM organised three (3) International seminars, eight (8) national seminars, three (3) expert consultations, two (2) forum, two (2) conferences, a multaqa, debate and workshop to enhance the understanding of society on Islamic principles.

A few of the seminars yielded important recommendations. The seminar on "Ulama the Inheritor of Ambia" proposed the creation of the post of "national mufti", as well as the formation of an autonomous body to oversee and streamline the role and activities of religious scholars (ulama) in the country.

The seminar on "Islamic Criminal Justice System" proposed that before the introduction of the Islamic Criminal Law (hudud), an International Panel of Ulamas be established to study its implementation in a multi-religious country. The seminar also suggested the establishment of a Malaysian Syariah Jurisprudence Department headed by a Syariah Attorney-General to advise the Federal and State Jurisprudence

Seminar yang bertajuk "Pemahaman dan Penerimaan Bioteknologi dari Perspektif Islam" mencadangkan penubuhan sebuah "Akademi sains hayat dan bioteknologi Islam antarabangsa". Seminar itu juga mencadangkan pembentukan sebuah Jawatankuasa Bioetika Kebangsaan untuk menggubal prinsip-prinsip etika bagi bidang bioteknologi dan bioperubatan dalam konteks undang-undang Islam.

Pada tahun 2003, IKIM telah menandatangani perjanjian persefahaman (MoU) dengan Universiti Monash Malaysia pada 27 Jun 2003; The Islamic Culture Centre Trust Fund, Mauritius pada 15 Ogos 2003; dan Pusat Penyelidikan Islam dan Minangkabau (PPIM) pada 23 Oktober 2003 untuk membuka laluan kepada usaha sama dalam kerja-kerja penyelidikan dan penganjuran seminar dan persidangan di antara pihak-pihak yang berkenaan.

Seminar mengenai "Nilai-nilai Islam Dalam Pembangunan Ummah" yang dianjurkan bersama Pusat Penyelidikan Islam dan Minangkabau (PPIM) mencadangkan supaya digubal satu indeks pembangunan Islam untuk mengukur tahap pembangunan di sesebuah negara Islam.

Buku terjemahan Pengembaraan Ibn Battutah telah berjaya diterbitkan pada tahun 2003. Terdapat beberapa buah buku dalam bahasa Arab yang sedang dalam proses terjemahan iaitu Al-Akhlaq Al-Islamiah Wa Ususuha Jilid 1 dan 2 (Prinsip-prinsip Akhlak Islam);

Department headed by a Syariah Attorney-General to advise the Federal and State governments on matters related to Islamic laws as well as the implementation of such laws.

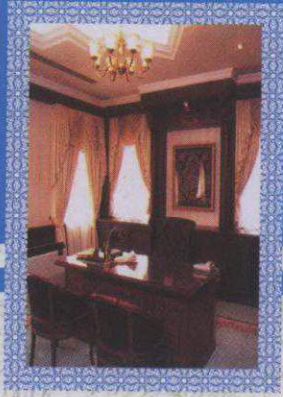
A seminar entitled "The Understanding and Acceptability of Biotechnology From Islamic Perspective" proposed the setting up of an "international Islamic academy of life sciences and biotechnology" dedicated to advance research and education. It also proposed the establishment of a National Bioethical Committee to formulate ethical principles in biomedicine and biotechnology in the context of Islamic laws.

During the year 2003, IKIM signed Memorandum of Understanding (MOU) with Monash University Malaysia on 27 June 2003; The Islamic Cultural Centre Trust Fund, Mauritius on 15 August 2003; and Centre For Studies of Islam and Minangkabau (PPIM) on 23 October 2003 to pave way for collaboration and cooperation in research projects and the holding of seminars and conferences between the signatories.

The joint seminar on "Islamic Values in the Development of Ummah" organized by Centre For Studies of Islam and Minangkabau (PPIM) and IKIM proposed the promulgation of Islamic development indices to measure development in any Islamic country.

The translation of The Adventure of Ibn Battutah from Arabic into the Malay language was completed in 2003. Other Arabic books in the process of translation are : Al-Akhlaq Al-Islamiah Wa Ususuha Volume 1 and 2 (Islamic Moral Principles); Ahkam Az-Zimiyin Wa Al-Musta'minin Fi Dar Al-Islam (Non-Muslim and Vagabond Law in Islamic Country); Adab Al-Qadhi,

Ahkam Az-Zimiyin Wa Al-Musta'minin Fi Dar Al-Islam (Undang-undang Kafir Zimani dan Peminta Sedekah di negara Islam); Adab Al-Qadhi, Jilid I (Etika Kehakiman Islam); dan Hujatullah Al-Balighah, Jilid I (Keterangan-keterangan Jelas Allah s.w.t.).

IKIM terus berusaha menerbitkan buku-buku dan terbitan-terbitan berkala. Pada tahun 2003, sebelas (11) buku ilmiah, dua (2) jurnal dan enam (6) isu majalah VISI telah berjaya diterbitkan.

Untuk tahun 2003, Radio IKIM.fm telah memperkenalkan Forum Bicara Ad-Deen yang bercorak jerayawara atau "road show". Pada tahun tersebut sahaja Forum Ad-Deen telah menjelajah ke 32 lokasi di seluruh negara. Forum ini bertujuan untuk memberikan kefahaman tentang Islam dengan lebih jelas kepada masyarakat disamping mendekatkan IKIM dengan khalayaknya.

Nilai dan mutu seminar-seminar anjuran IKIM banyak bergantung kepada penyertaan pakar-pakar Islam daripada luar negara. Antaranya ialah Sheikh Dr Hishamuddin al-Qaraqira, Rektor Universiti Antarabangsa Beirut; Sahhibul Fadhilah Dr Zainol Abidin Ahmad Muhammad Jabar Al Zuwaidi, wakil Sheikh Al-Azhar; Sahhibul Fadhilah Dr Muhammad Addu Rabbah as-Sibhi, wakil daripada Mesir; Sahhibul Samahah Syed Isa bin Mohamed bin Semait, Mufti Singapura. Tuan Yang Terutama Mr. Justice Chaudhary Ejaz Yousaf, Chief Justice, Federal Shariah Court of Pakistan, Prof. Dr. Ibrahim Sulayman, Presidency of Sharia Court, Nigeria; Mr. Mohamed Lufti Hussin, Singapura; Y.A. Dato' Seri Setia Awang Hj. Metussin Hj. Baki, Hakim Mahkamah Syariah Brunei Darussalam; Bapak Drs. H. Taufik S.H. M.H., Mahkamah Syariah

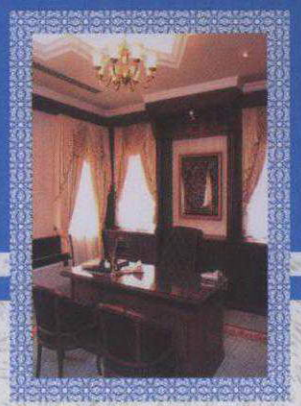

IKIM continues to publish books and periodic publications. For the year 2003, eleven (11) books, two (2) journals and six (6) issue of VISI magazine were published.

In the year 2003, Radio IKIM.fm introduced a programme called "Forum Ad-Deen", a road show programme which directly broadcast from thirty two (32) locations nationwide. Its objective is to provide the society a clear understanding of Islam besides bringing Radio IKIM.fm closer to its audience.

The quality of IKIM seminars is mainly derived from the participation of many foreign Muslim scholars. Among them were Sheikh Dr Hishamuddin al-Qaraqira, the Rector of Beirut International University; Sahhibul Fadhilah Dr Zainol Abidin Ahmad Muhammad Jabar Al Zuwaidi, the representative of Sheikh Al-Azhar; Sahhibul Fadhilah Dr Muhammad Addu Rabbah as-Sibhi, representative from Egypt; and Sahhibul Samahah Syed Isa bin Mohamed bin Semait, the Mufti of Singapore. Hon. Mr. Justice Chaudhary Ejaz Yousaf, Chief Justice, Federal Shariah Court of Pakistan, Prof. Dr. Ibrahim Sulayman, Presidency of Sharia Court, Nigeria. Mr. Mohamed Lufti Hussin, Singapore, Y.A. PERPUSTAKAAN

LIBRARY

Koleksi buku di Perpustakaan telah bertambah sebanyak 18,369 naskhah. Selain itu, koleksi jurnal dan majalah telah meningkat sebanyak 28 naskhah, koleksi pita video sebanyak 980 dan kertas kerja seminar atau persidangan sebanyak 219 naskhah. Manakala Perpustakaan IKIM Pahang mempunyai koleksi sebanyak 3,303 naskhah.

Untuk keperluan sistem Automasi Perpustakaan IKIM, perisian BRS Search atau Advanced Library Information Facilities (ALIF) telah diwujudkan. Manakala bagi aktiviti mengelaskan dan mengkatalogkan buku-buku di Perpustakaan, sistem Library of Congress Subject Headings dan Library of Congress Classification Number pula telah diguna pakai.

The book collection in the library has increased to 18,369 volumes. The journal and magazine sections acquired 28 copies, video tapes increased to 980 copies. There were 219 working papers collected from seminars and conferences. The IKIM Library in Kuantan has a collection of 3,303 books.

BRS Software known as Advanced Library Information Facilities (ALIF) was designed to cater for the need of the library automation system. Meanwhile, for the classification and cataloging of books, Library of Congress Subject Heading and Library of Congress Classification Number have been used.
